1. If you are an international student with F1, F2 or J1 visa status, please see “Insurance” information on the [International Student Services \(ISS\) web page](#).
2. If you are a non-international student and have already purchased health insurance for fall (August 1 through December 31, 2020) or if you are not interested in obtaining health insurance, you may disregard the remainder of this memo.
3. If you are a non-international GTA/GRA/GA with no fall appointment or with less than a 50% GTA, GRA, or GA fall appointment who purchased the graduate student health insurance plan for the summer 2020 semester, will be returning to KU in the spring, and are interested in purchasing health insurance for August 1 through October 31, 2020,

If you are a non-international GTA/GRA/GA with no fall appointment or with less than a 50% GTA, GRA, or GA fall appointment who did not purchase the graduate student health insurance plan for the summer 2020 semester but are interested in purchasing health insurance for August 1 through December 31, 2020, please go to www.uhcsr.com/ku, scroll to the Domestic Students Medical box, click on “Explore Policy.” Online enrollment is available by clicking “Enroll Now.” The deadline to purchase this insurance is November 30, 2020. Eligibility requirements apply.

If you are a non-international GTA/GRA/GA with at least a 50% GTA, GRA, or GA appointment for a minimum of 8 consecutive work weeks during the fall and are interested in purchasing health insurance for August 1 through December 31, 2020, [click here for online enrollment – available after July 20th](#)
